## 4. Confirmation of minutes from Board meeting held on 8<sup>th</sup> Aug and 30<sup>th</sup> Aug 2023

MOTION (23-09)-1: That the minutes be accepted as a true record of the last board meeting. Proposed Drew, Seconded Lindasy. CARRIED.

#### 5. Matters arising

- a. Letter of complaint: Mart Bosman re Alice Springs GC and NT Soaring. Review by MPIO Alf McMillan.
  - Mart has complained about Board decision.
  - We have asked Alf McMillan to reviews steps taken in the preliminary investigation to check that all reasonable steps have been completed.

### b. That QLD/SANT propose a revised funding distribution model –

Peter Brooks presented a proposal for future subsidy distribution from Gliding Australia to the Regions based on range of variables (refer to document in Board meeting drive):

- a subsidy increase proportional to the % of the membership fee when the current \$12 subsidy was established (thought to be 5%), and
- the subsidy would be partly a flat fee to cover fixed expenses and partly based on regional membership numbers.
- This was discussed with no determination made, but it was proposed to subsidise SA and QLD \$3000 each for the remainder of this financial year

MOTION (23-09)-Moved by Chris Bowman, Seconded Viv Drew. Carried.

- c. Governance and Integrity documentation Defer to next meeting.
- d. Accountability of Clubs and Regions next stage. Decided to defer for the new Board to discuss.
- e. Regional strategic alignment and KPIs Jenny. Decided to defer for the new Board to discuss.
- f. World Gliding Championships progress.
  - Progressing without problems.
  - Financial letter from Beryl needs improvement, needs to confirm that the Organisation and the club will not ask for any other support. We should draft a letter for her.
- g. AGM: Proposal to change EOFY from 30/04 to 31/08.
  - 47 Proxies so far, 53 registered to attend.
  - We require further promotion to ensure we get enough votes (100 required)

  - We should use CASA green paper to our advantage

- c. Aviation Green Paper
  - GFA needs to respond or the big end of town will hold sway.
  - Talk about electric propulsion. Invite others to the Jonker Sailplane course on electric gliders
  - We are part of the grass roots of aviation in this country.

- e. 7 Sept: AAFC: Requesting us to Invoice them for Memberships rather than prepayments Discussed and addressed.....
  - AAFC MOU agrees that they will pay.

- Gliding Australia MOSP requires payment up front. Required rule by CASA.
- AAFC have now agreed to pay \$10,000 up front.

Anthony: A member with AW qualifications has a problem with alcohol. This Led to reviewing the Drug and Alcohol Policy which was fairly operations focussed. Taken information from operations and included that into the policy, inserted references to maintenance activities.
